#### AFTER MY TOUR OF DUTY ON THE YANCEY Ed McLaughlin RM3 11/65 -11/67

After my discharge I returned to my career as a radio announcer and newscaster in Pittsburgh, Pa. Shortly after my return the radio station was sold to a multi-station group. They brought in their own crew of DJ's and gave me the News Directors position. After a year I left radio and changed my life's direction. I went to work for a multinational manufacturing company in a sales and training position. Some of the products being made were safety products for firefighters. Having been a volunteer firefighter in my little hometown it was a perfect fit. I was trained and transferred to Los Angeles as the Sales and Training Manager. If you remember the tv show "Rescue 51", I was the trainer to the actors in the correct use of our helmets and breathing apparatus. I got my "2 minutes of fame" on camera when they shot several scenes of me teaching "Johnny and Roy" and others in a classroom setting. After 8 years in California, I was transferred to the Pacific Northwest and located out of the Seattle office. There were several fantastic and exciting places where I was sent to teach like inside a missile silo in Minot N. Dakota, Three Mile Island Nuclear Generation Plant, The USS Nimitz, U.S. Air Force Bases outside the USA, and the oil drilling project in Prudhoe Bay Alaska. I made many trips to Alaska training in fire departments and military bases throughout the state. This photo shows a large grizzly bear about to enter the fire department engine bay where I was teaching. You can see the guard frantically waving his left arm for someone to hit the button to close the bay doors while at the

same time using his right hand to reach for his hand gun. They later told me

that on more than one occasion a wild animal has wandered in the Station. This picture shows a view of a drilling operation on a [man-made] island several miles out in the Arctic Ocean. I took this picture as we were turning toward the "Ice



Runway" just before landing. The temperature was about 40 degrees below zero and the ice was very, very thick around the island. The third

picture shows a year-old polar bear cub chasing one of the employees around and around his truck.



He just did not have time to get his truck door open and jump in. I took the picture from the cab of a fire rescue truck they used to scare the cub away. The final picture was taken on December 12, 2005 at noon. You can

see the dot of the sun, and the bottom part of the very large moon above it. This was the shortest day of the year in 2005. You will also

note the ice ridge and the open water around the island.
